Metro Flood Diversion Authority Board of Authority Meeting Minutes

3:30 PM – November 21, 2024 City of Fargo Commission Chambers

A regular meeting of the Metro Flood Diversion Authority Board of Authority was held on November 21, 2024. The following members were present: Bernie Dardis, Mayor, City of West Fargo; Dr. Tim Mahoney, Mayor, City of Fargo; Chuck Hendrickson, Moorhead City Council; David Ebinger, Clay County Commissioner; Kevin Campbell, Clay County Commissioner; Mary Scherling, Cass County Commissioner; Tony Grindberg, Cass County Commissioner; Larry Seljevold, Moorhead City Council; Rick Steen, Cass County Joint Water Resource District; Dave Piepkorn, Fargo City Commissioner and Chad Peterson, Cass County Commissioner.

Member(s) absent: Shelly Carlson, Mayor, City of Moorhead and Denise Kolpack, Fargo City Commissioner.

1. CALL TO ORDER

Mr. Grindberg called the meeting to order at 3:30 PM. Roll call was taken, and a quorum was present.

2. APPROVE THE MINUTES FROM THE OCTOBER 2024 MEETING

MOTION PASSED

Mr. Steen moved to approve the minutes from the October 24, 2024, meeting and Mr. Hendrickson seconded the motion. On a voice vote, the motion carried.

3. APPROVE THE ORDER OF THE AGENDA

MOTION PASSED

Mr. Steen moved to amend the order of the agenda, removing item 4.c., ii, from the Consent Agenda and placing it on the December agenda. Mr. Hendrickson seconded the motion and on a voice vote, the motion carried.

4. APPROVE THE CONSENT AGENDA

MOTION PASSED

Mayor Mahoney moved to approve the Consent Agenda as amended and Mr. Ebinger seconded the motion. On a roll call vote, the motion carried.

5. CO-EXECUTIVE DIRECTOR'S UPDATE

a. Executive Director Employment Agreement

Mr. Shockley provided an overview of the final executive director's employment agreement and noted that it has been agreed to and signed by Mr. Benson.

MOTION PASSED

Mayor Mahoney moved to approve the employment agreement as presented and Mrs. Scherling seconded the motion. On a roll call vote, the motion carried.

6. GENERAL COUNSEL UPDATE

Mr. Shockley did not have an update.

7. PROJECT UPDATES

a. USACE Project Update

Ms. Williams provided the following USACE update:

1 Diversion Inlet Structure (DIS) - Construction

Structure includes 3-50 ft. wide Tainter gates. Construction is 99% complete. Construction completion date will be revised pending outcome of modifications to the gate machinery design. Schedule for remaining work: 2024-2025: Complete operating machinery corrections; training and commissioning.

2 Wild Rice River Structure (WRRS) - Construction

Structure includes 2-40 ft. wide Tainter gates. Construction is 98% complete. Construction completion date will be revised pending outcome of modifications to the gate machinery design. Schedule for remaining work: 2024-2025: Complete operating machinery corrections; training and commissioning.

3 I-29 Raise - Construction

Includes approximately 4 miles of interstate raise between County Roads 16 and 18. Construction is 100% complete. Final inspection held 3 January 2024; turf establishment inspection held 29 August. Preparation of O&M documents and turnover is ongoing.

4 Red River Structure (RRS) - Construction

Structure includes 3-50 ft. wide Tainter gates. Construction is 70% complete. Construction completion date is 19 March 2026. Tainter gate #2 continues to be assembled on site and construction of dam walls and placement of riprap ongoing.

5 Drain 27 Wetland Mitigation Project Plantings - Construction

Native plantings 5-year contract awarded 17 May 2023. Completion date for wetland establishment is 1 December 2027. Encroachments continue to be an issue.

6 Drayton Dam Mitigation Project Design - Construction

Construction is complete. Turnover to MFDA for O&M occurred on 28 Nov 2023. OMRRR manual will be finalized once MFDA provides comments.

7 Southern Embankment – Reach SE-2A - Construction

Construction is 75% complete but continues to be behind schedule. Scheduled completion date of 13 October 2024 was not met.

8 FY2024 Contract Awards:

OHB Ring Levee: Awarded 22 February and is 12% complete. Inspection trench, earthwork and storm sewer activities ongoing. Contract completion date is 31 August 2025.

Reach SE-1B: Awarded 27 February and is 23% complete. Stripping, hauling, road subgrade and box culvert work continues. Contract completion date is 13 March 2026.

Reach SE-2B: Awarded 11 March and is 30% complete. CR 16 to be opened for winter. Contract completion date is 30 October 2025.

Forest Mitigation #1: Contractor is preparing lands for additional planting next season. Reach SE-4: 130th realignment and north embankment work ongoing. Contract completion date is 3 June 2026.

9 FY25 Contract Awards:

SE-3: Bid opening currently scheduled for 19 November. Contract award: January 2025.

SE-5: Bid opening currently scheduled for 3 December. Contract award: January 2025.

Forest Mitigation #2: Advertise in December. Award in February 2025.

Mr. Barthel also reported that the total paid to RRVA to date is \$5,108,801, and it is anticipated that \$235,110,410 will be paid to them in 2025. 9. LAND MANAGEMENT UPDATE

a. Property Acquisition Status Report

Ms. Smith provided the following property acquisition status report:

- 97.7% completion in the Construction Footprint
- 55.5% completion in the UMA Footprint
- 93.2% of the parcels in the Southern Embankment have been acquired
- 55.5% of the parcels in the Upstream Mitigation Area have been acquired
- 77.0% of the Environmental Easements have been signed
- 100.0% completed: Stormwater Diversion Channel; Oxbow-Hickson-Bakke levee; in-town levees and the Drayton Dam mitigation

Key Activities:

- Continue negotiating settlement agreements for existing eminent domain actions
- In the last month, successfully closed on 4 parcels / 4 owners in the UMA
- Continuing the process of disposing of Excess Lands
- 30 parcels / 333.18 acres have been approved as Excess Lands
- 8 parcels / 196.71 acres are moving through the Policy
- 22 parcels / 136.47 acres have been sold or pending closing
- Starting to receive appraisal reports for Christine area flowage easements
- Continued work on farmland leases for 2025
- Reminder: The vacate dates for occupied Minnesota properties
- Deadline in Clay County = April 1st, 2025
- Deadline in Wilkin County = June 1st, 2025

10. FINANCE UPDATE

Mayor Dardis reported that the November bills payable total \$8,277,666, and the current grand total net position is \$302,630,687. Mayor Dardis also reported that \$17,113,000 has been received in revenues this month and the sales tax revenues will continue to be monitored.

a. Sales Tax Update

Mr. Shockley provided an overview of the sales tax sunset dates and the new sales taxes that were voted on and approved at the June election.

b. MFDA 2023 & 2024 Contract Summary

Mr. Barthel reported that the contract summary has been reviewed and the 2023-2024 open contracts will be closed out as soon as they can be.

11. OTHER BUSINESS

a. Resolution of Support for MN Funding Request

Mr. Campbell reported on the proposed resolution of support that Clay County and the City of Moorhead will take to Minnesota legislators in hopes of securing \$60.4 million in funding for the Moorhead in-town and Clay County flood projects.

Mayor Mahoney moved to approve the resolution in support of the Minnesota entity's funding request and Mr. Peterson seconded the motion. On a roll call vote, the motion carried.

b. ND AGRICULTURAL WEATHER NETWORK PRESENTATION

Mr. Daryl Ritchison, director of NDAWN and state climatologist, gave a presentation on the NDAWN capabilities and described how they complement and support the project.

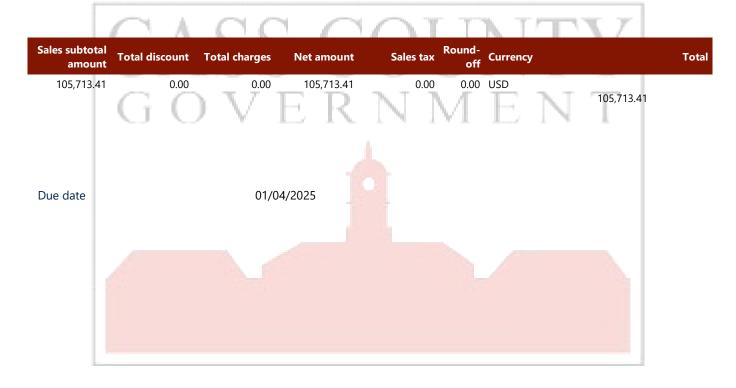

Metro Flood Diversion Authority, North Dakota political subdivision, 4784 Amber Valley Parkway S. STE 100 Fargo, ND 58104, herein called "Customer".	

WHEREAS, Customer has requested a natural gas extension, hereafter referred to as the "Project" to be constructed in accordance with Montana-Dakota's Gas Service Extension Policy, hereafter called "Rate 120", as described below:

Provide natural gas service to Joe Sauvageau home, shop, and grain dryer located at 16837 48th Street SE, Davenport, ND 58021

WHEREAS, the Project will necessitate the construction by Company of a gas main extension and the installation of necessary facilities. NOW, THEREFORE, in consideration of the mutual covenants herein contained, it is hereby agreed as follows:

- 1. **Project.** Company shall construct and install gas mains and facilities for the Project, in accordance with Rate 120. "Project" as used herein shall include gas main extension(s), valves, service line(s), regulators, meters, any required payments made by the Company to the transmission pipeline company to accommodate the extension(s), any permits required to construct the extension, and other costs up to, and including the riser.
- 2. **Cost Contribution.** The estimated Maximum Allowable Investment (MAI) for the Project is \$\frac{65,370.00}{.}\$. Customer shall be required to pay to Company the total estimated cost for the Project, in the sum of \$\frac{1,078,426.00}{.}\$ (the "Cost Participation"), to be paid as follows:

Cash Payment

The Cost Participation shall be made prior to the start of construction.

- 3. **Cost True-Up.** The costs presented herein are the estimated cost for the Project and shall be subject to an actual cost true-up as provided in Rate 120. The true-up may result in an additional charge or refund to Customer.
- 4. **Recalculation of MAI.** The estimated MAI is only provided for reference and Customer's actual MAI will be determined based on the following:
 - a. For non-residential customers, Customer's actual usage during the five (5) year period from the Project's in-service date; and
 - b. Whether additional customers have connected to main installed as part of the Project. Company shall, at the end of each of the first five annual periods from the in-service date of the Project, determine if any additional customers have connected to the Project. Company will refund the original Customer that executed this Agreement the Net Allowable Investment, as shown in the Maximum Allowable Investment Calculation, for each additional service point initiated during the five (5) year period following the in-service date of the Project.

"In-service date" shall be the date Company completes construction of the Project. Company, in its sole discretion, will determine if Customer's actual MAI will be refunded either in part or whole prior to five (5) years from the in-service date of the Project. No refund will be made after five (5) years from the in-service date of the Project and total refund amount shall not exceed the Cost Participation.

- 5. **Margin.** Customer agrees that there shall be a minimum annual margin requirement under this agreement in the sum of \$_0.00\]. Customer also agrees that the difference between actual annual margin paid to Company and the minimum annual margin requirement will be invoiced to Customer annually during the term of this Agreement.
- 6. Cancellation. Company reserves the right to cancel this Agreement if the Applicant defers construction for more than six (6) months from the date of this Agreement or has not prepared the locations where the Project is to be constructed to a condition sufficient for Company to begin construction within six (6) months of the date of this Agreement. If the Agreement is cancelled, Company will refund any deposit made by Customer, less any costs incurred by the Company related to the Project, and, thereafter, all parties shall be relieved from any and all further liability in connection with this Agreement.
- 7. **Title.** All equipment installed under the terms of this Agreement shall at all times be and remain the sole property of Company.

8. Additional Terms. The following additional terms and conditions shall apply to Company's construction of the Project:

Attached Addendum A is incorporated herein and as part of this agreement

- 9. Incorporated Documents. The following documents are attached hereto, and incorporated herein, as part of the Agreement:
 - a. Customer Application for Gas Service;
 - b. Construction Cost Summary;
 - c. Maximum Allowable Investment Calculation;
 - d. Map of Project; and
 - e. Gas Service Extension Policy, effective as of the date of the execution of this Agreement, which is available at https://www.montana-dakota.com/rates-services/rates-tariffs/. In the event of any conflict, the language of Rate 120 shall control.
- 10. **Future Service.** This Agreement does not include the provision of natural gas service. Natural gas service will be provided in accordance with Company's applicable tariffs on file with the North Dakota Public Service Commission. Company reserves the right to charge Customer the entire cost of the Project if Customer has not initiated service within twelve (12) months of the date of installation.
- 11. **Miscellaneous.** This Agreement contains the entire agreement of the parties and may be changed only by an instrument in writing executed by both parties. This Agreement shall be binding upon and inure to the benefit of the parties, their respective successors, and assigns; but the assignment of this Agreement by either party shall not relieve such party, without the written consent of the other, from any of the obligations undertaken by this Agreement.

Addendum A

Large Customer Gas Service Extension Agreement (Rate 120)

- 1. **Contingencies.** The Large Customer Gas Service Extension Agreement (Rate 120) (the "Agreement") shall be subject to the contingencies listed below.
 - a. Company's ability to secure all necessary permits and easements for the Project. These may include but are not limited to highway permits, railroad permits, private easements, etc.
 - b. WBI Energy Transmission Inc.'s Wahpeton Expansion Project being permitted, constructed, and completed on schedule.
 - c. The North Dakota Public Service Commission's approval of a Certificate of Public Convenience and Necessity to serve the location described in the Agreement.

Should any of these contingencies fail, this Agreement will terminate and, if applicable, the Customer's Cost Participation will be refunded less the costs already incurred for the Project, including efforts to secure the necessary permits or easements.

- 2. Company and Customer (collectively, the "Parties") acknowledge that Customer will not be the actual natural gas "customer" at the location described in the Agreement, and instead, Joseph Sauvageau, a third party ("Sauvageau"), will be the person executing necessary Application for Service Agreements and an Interruptible Gas Service Agreement for natural gas service at the location. Sauvageau received a copy of the Agreement and acknowledges, below, that he has read and fully understands all provisions therein, voluntarily assents to the terms and conditions therein, and has done so under his own volition. Sauvageau further acknowledges and agrees that Customer shall be entitled to any MAI refund payable under the Agreement.
- 3. **Additional Costs.** Customer acknowledges that additional, unanticipated costs may be incurred as part of the Project. Customer will be responsible for any additional costs, including but not limited to, costs incurred by Company due to abnormal and/or unusual conditions, winter construction, and changes to the Project after the start of construction. These costs shall be non-refundable. Company shall invoice Customer for these costs, and payment shall be made by Customer to Company within thirty (30) days of the invoice date.
- 4. **Governing Law.** The Agreement shall be governed and enforced in accordance with North Dakota law. 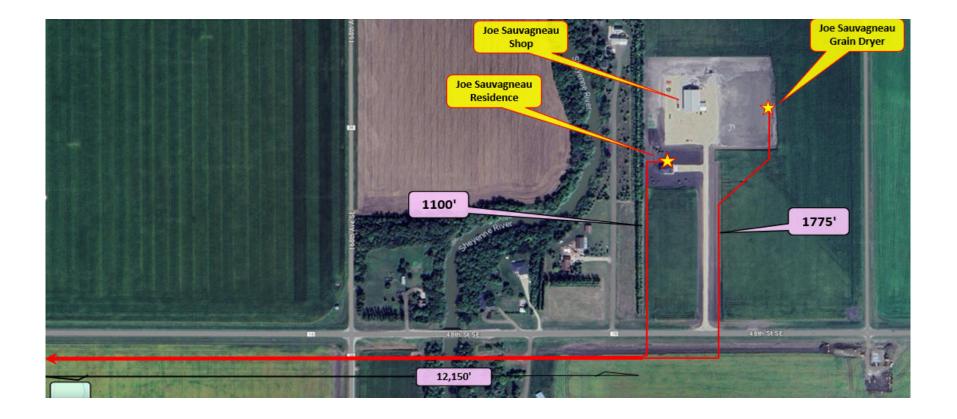

Structure includes 3-50 ft. wide Tainter gates. Construction is 99% complete. Construction completion date will be revised pending outcome of modifications to the gate machinery design. Schedule for remaining work: 2024-2025: Complete operating machinery corrections; training and commissioning.

2 Wild Rice River Structure (WRRS) – Construction

Structure includes 2-40 ft. wide Tainter gates. Construction is 98% complete. Construction completion date will be revised pending outcome of modifications to the gate machinery design. Schedule for remaining work: 2024-2025: Complete operating machinery corrections; training and commissioning.

3 I-29 Raise – Construction

Includes approximately 4 miles of interstate raise between County Roads 16 and 18. Construction is 100% complete. Final inspection held 3 January 2024; turf establishment inspection held 29 August. Preparation of O&M documents and turnover is ongoing.

4 Red River Structure (RRS) - Construction

5 Drain 27 Wetland Mitigation Project Plantings - Construction

Native plantings 5-year contract awarded 17 May 2023. Completion date for wetland establishment is 1 December 2027. Encroachments continue to be an issue.

6 Drayton Dam Mitigation Project Design - Construction

Construction is complete. Turnover to MFDA for O&M occurred on 28 Nov 2023. OMRRR manual will be finalized once MFDA provides comments.

7 Southern Embankment – Reach SE-2A - Construction

Construction is 75% complete but continues to be behind schedule. Scheduled completion date of 13 October 2024 was not met. Revised schedule and completion date pending.

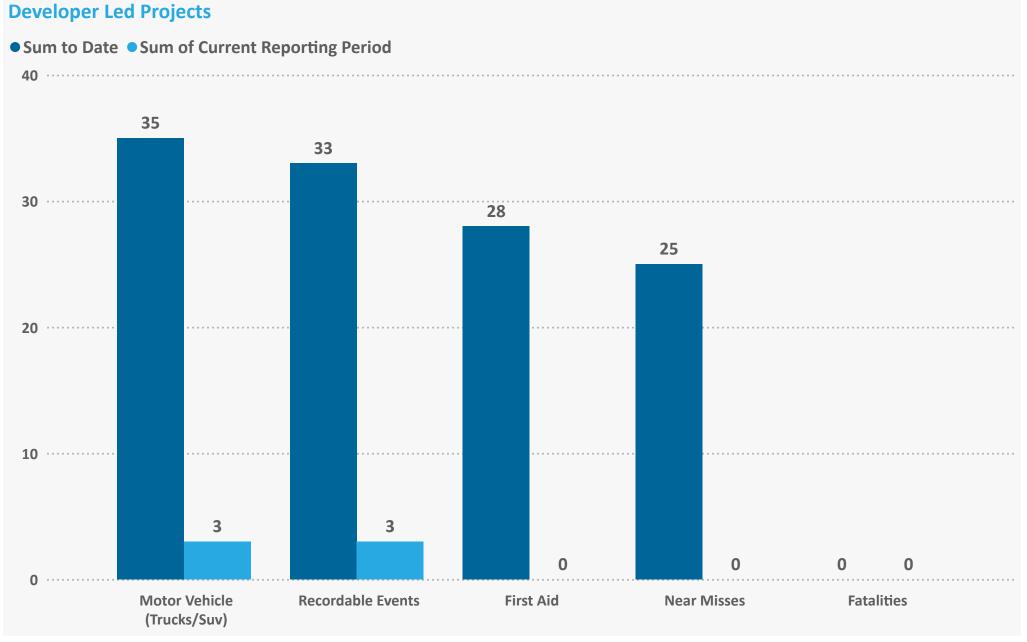

PROGRESS

Construction of the SWDCAI is approximately 52% complete based on Earned Value from RRVA's latest Schedule Submittal. The work during the reporting period is summarized below.

- General: Work project wide has been constrained this period by adverse weather.

COMMERCIAL

Compensation and Relief Events

By the end of November 2024, RRVA had submitted notices of 28 (twenty-eight) Compensation Events and 2 (two) Relief Events. A summary and status of the Compensation Events and Relief Events is in *Attachment B – Submitted Compensation Events (CEs) and Relief Events (REs)*.

Change Requests

A change request (CR) can be initiated by the Authority or RRVA, and it is the mechanism set out in the Project Agreement to modify the Technical Requirements to resolve issues, clarify requirements, or modify the scope of RRVA's work.

There have been 23 (twenty-three) Authority-initiated change requests (ACRs) through the end of the reporting period. 12 (twelve) have been agreed to and progressed to agreed-upon change orders, totaling a cost to the Authority of \$8,355,700.38 and a credit to the Authority of \$950,000. 3 (three) ACRs were withdrawn, and 6 (six) are pending negotiation with RRVA. A summary of the ACRs is in *Attachment C – Authority Change Requests*.

There have been 55 (fifty-five) developer-initiated change requests (DCRs) through the end of the reporting period. 34 (thirty-four) have been agreed to and progressed to agreed-upon change orders, totaling \$3,745,113.13 cost to the Authority. 1 (one) is pending negotiation with RRVA. A summary of the DCRs is in *Attachment D – Developer Change Requests*.

PROJECT CONTROLS

Schedule

² The Developer and the Authority has entered into a 'without prejudice' agreement, and an extension thereto, for the Developer to incorporate epoxy-coated reinforcing steel into those structures that do not yet have Released For Construction Documents.

The Developer submitted the twenty-fifth Project Status Schedule (PSSU) update on or about November 15, 2024, for the month of October 2024 (01-Nov-24 Data Date). The submittal was accepted for review. To create the PSSU, the Developer reported making approximately 43,220 changes to the previous PSSU, including new and deleted activities, changes to logic and relationships between activities, activity description changes, calendar changes and activity duration modifications. The Project Substantial Completion Date in this PSSU is March 24, 2027, which differs from the September 2024 PSSU Project Substantial Completion Date by fifteen days (April 8, 2027). The approved PBS Project Substantial Completion Date (Scheduled Project Substantial Completion Date) is October 1, 2026 – a difference of 174 days from the October 2024 Project Substantial Completion Date.

Work continues with development of the Interim Completion Certificate for Project Elements procedure. Information is being gathered from the PA, TR's and the Element definitions to construct an "Element Completion Matrix" identifying roles, responsibilities and inputs from the PMC P3 team to satisfy the requirements of Section 23 of the Project Agreement. This effort includes a core group from Quality, Project Controls and Project Management but will be expanded to include all stakeholders as the process develops.

Invoicing and Payment

BNSF has submitted 66 invoices, which have been forwarded to the Developer for payment for work performed by BNSF and its subcontractors at the Prosper, Hillsboro and KO Shooflies. 55 of the 66 were paid for a total of \$6,647,440.93. The BNSF Construction and Maintenance Agreement (C&M Agreement) between the Authority and BNSF is considered a "Third Party Agreement" as administered under Section 11 of the Project Agreement. Therefore, the invoices received by the Authority are transmitted to the Developer for payment directly to BNSF within 60 days of the invoice date according to Section 7 of the C&M agreement. Future invoices received will be handled in a like manner.

CONSTRUCTION AND O&M

Construction

Construction activities by buildable unit (BU) during the reporting period are provided in Attachment A – Construction Progress by Buildable Unit.

O&M

RRVA's local contractor discontinued mowing ditches and has shifted efforts to ensuring ditches and culverts are free from debris in preparation for the upcoming Winter months.

Safety

The following safety-related matters occurred during the reporting period:

- 11/1/2024 ASN Maple River Aqueduct, employee was attempting to clear the telehandler forks of debris by bumping the tilt controls while moving. The Telehandler started bouncing and the fork on the non-operator side went into the ground causing the fork to bend.
- 11/1/2024 ASN Reach 10, employee in an ASN pickup backed into his personal vehicle. No injuries were reported, however damage occurred to personnel vehicles.
- 11/2/2024 ASN Reach 11, Tractor with towed scraper encountered a high spot while scraping material from the left drainage ditch. The high spot caused the battery door to bend and latch bolt to break.
- 11/5/2024 BNSF had a Mandatory Safety Stand Down for all sites due to a BNSF employee killed in train-truck collision in New Rockford, ND late Monday morning.
- 11/5/2024 ASN Reach 01, employee was electrocuted during demolition of an abandoned electrical line.
 Employee was life flighted to a local hospital. Ongoing OSHA investigation as of the date of this summary report.
- 11/11/2024 ASN 32nd Ave W Crossing, Employee was helping another employee drill a hole for form-ties by pulling a rod to the side with a hammer, the paddle drill bit grabbed the employee's gloved finger and took the top portion off the finger by the joint. The employee was taken to the hospital where they could not reattach the portion of the finger. OSHA was notified by ASN.
- 11/14/2024 ASN Reach 10, employee inhaled smoke/fumes when the dozer he was operating malfunctioned. He shut down the machine immediately, but 30 minutes later he began to feel nauseous and vomited. He was taken to the clinic and checked-out ok.
- 11/18/2024 ASN Reach 01, employee was driving westbound in the rain when the employee was caught off guard by a turn and slammed on the brakes, the front end of the vehicle slid off the road. As the employee was backing up, they made contact with a road reflector post, causing minor damage to the door.
- 11/22/2024 ASN All Hands Safety Meeting held at Maple River Aqueduct's equipment yard.
- 11/27/2024 ASN employee attempting to stop at an upcoming intersection (Veterans Blvd and 26th St) hit a patch of ice causing the ASN vehicle to slide into the back of another vehicle which caused that vehicle to hit a 3rd vehicle. No injuries were reported.

Testing

Survey GIS

The following locations were surveyed for compliance:

Location survey of area mined for Sherack material to save importing from another source thatwould require
materials testing by BNSF. This was noted for record only.

Cass County Monitoring of County Bridges (by HMG)

HMG had two monitors on site at least once at each bridge location per day.

Daily Observations/Compliance Check

The PMC team conducted on behalf of the Authority: (1,483) observations in the November 2024 reporting period; (76) compliance checks were conducted for compliance referencing the Technical Requirements and the Released for Construction (RFC) Documents. (26) issues were noted that the Contractor was able to resolve readily.

UTILITIES:

- To date RRVA has submitted 297 Utility Design submittals for review; 61 Preliminary Design Reports (PDRs); 121 Final Design Reports (FDRs), of which 42 are resubmittals; and 115 Construction Documents (CD) submittals, including 32 resubmittals.
- All Preliminary Design Reports by the Developer (61) are approved.
- All Final Design submittals (79) are approved.
- 96% of Construction Document submittals (80 of 83 total) for utility relocations have been approved.
- 80 sets of RFC Documents have been approved for 102 Utility Buildable Units (BUs). This is 97% of the 105 BUs in RRVA's scope of work.
- 98.7% (220 of 223) of the total anticipated utility design submittals (PDR, FDR & CD) have been approved.
- 107 Inspection and Test Plans (ITPs) have been approved for Utility activities.
- 51 shop drawing submittals for Developer managed Utility relocations are approved.
- Overall, 31 of 108 identified utility conflicts (29%) have all work including HDD void grouting and removal of abandoned facilities completed.
- Relocations for 53 of the 61 utilities to be buried under the channel are tied-in or cut over.
- Abandoned/retired utility facilities have been removed for 31 Utility Buildable Units.
- The voids have been grouted on both the entry and exit sides at 34 HDD installations. Grouting was completed at 4 locations in November. Seven bores still require grouting on both sides and 3 require the HDD void to be grouted on one side only.
- Adjustments for only 2 of the 14 overhead electric transmission lines crossing the channel ROW are complete, the Otter Tail Power (OT1) 115 kV line to remain in place and the Xcel Energy (XE3) 230 kV line south of 32nd Ave W.

TECHNICAL

Design Review

Progress continues to be made with submittal, review, and completion of design documents. Developer forecast of a late August completion for all design documents continues to be delayed. Revisions to previously "Released for Construction" documents is the emphasis this reporting period. These changes predominantly reflect the introduction of epoxy coated rebar to multiple buildable units. Various drivers are contributing to this delay, drivers solely the responsibility of the Developer.

- Commercial negotiations regarding the introduction of meanders in the Aqueduct design documents was
 completed this reporting period. Initial schedule for receipt of the revised plans has not been achieved by the
 Developer. Initial indication from the Developer is that the meanders will be added with changes which will
 be made to modify the flume and gates to allow for scheduled maintenance of the aqueduct flumes.
- Minor and Field adjustments to design documents continue to be submitted by the Developer and reviewed by the Authority and AHJ's for integration into the project.
- Developer resolution of Rush River Drain construction has been determined. Developer stated that they will reconstruct to meet the original RFC documents.
- Concerns have been raised by Agencies and Authority regarding the As-Built condition of the Diversion Outlet.
 Verification efforts are underway by both the Developer and the Authority. Concerns are focused on weir boulder size, layout, and embedment. Anticipate data compilation to confirm in place condition and configuration should be completed next month.
- Authority Administration Building design has been re-started. Several very productive meetings both internally and with City of Fargo have taken place. Anticipated design completion in spring of 2025.

Agency Coordination

- Agency specific coordination and design comment clarification meetings continue this reporting period. Biweekly and as required meetings are being held with the following agencies.
 - Authority coordination and engagement, focusing on communications between Agencies and the Developer is yielding positive results. All parties have committed to maintaining open lines of communication. Overall, these efforts are very beneficial to overall delivery.
 - Additional refinements to in-place processes for AHJ inclusion in the review of Requests for Information (RFI) have been incorporated.

NDDOT

- No significant concerns this reporting period
- Standing coordination meetings with NDDOT continue.
- There are no technical issues or concerns to report currently.
- Communication between NDDOT, Authority and Developer continues to be effective and beneficial to all parties.

Cass County

- No significant concerns this reporting period
- Standing coordination meetings with Cass County continue.
- There are no technical issues or concerns to report currently.
- Cass County representatives have participated in "walk-thru's" of structures nearing completion.

BNSF

- Standing coordination meetings with BNSF continue.
- Coordination and communication with BNSF leadership and staff remains good.
- Resolution of clarifications, questions and minor revisions has been accomplished with minimal issue.

Challenges

- Clarification of 3rd party designs yet to be made available to the Authority
- Developer incorporation of comments in the H&H model
- Modification of Aqueducts to provide ability to comply with maintenance requirements
- Resolution of non-conformances which may require design and or construction modifications (Diversion Outlet)

Successes

- Continued positive progress on development of Authority Administration Building (AAB)
- Agreement between Authority and Developer regarding incorporation of epoxy coated rebar in select structures which will allow construction to proceed – resolution of commercial component of this matter yet to be achieved.
- Resolution of commercial component which provides introduction of meanders into the aqueduct designs.

ENVIRONMENTAL

Environmental Compliance

2024 Section 404 Permit Special Condition M: The Developer has concluded it will reconstruct the Rush River Inlet to the accepted RFCs in Spring 2025. This allows the Authority to submit required documentation to satisfy Special Condition M for the Rush River Inlet and this documentation is in final review before submittal to USACE. When appropriate, similar documentation is required for both the Sheyenne and Maple Rivers Aqueducts.

Permanent native vegetation planting occurred during this construction season in 2024. 3,508 trees were planted, and 1,077 acres of native grasses were seeded in Reaches 1, 2 and 3 this year.

<u>2024 404 Permit</u> – RRVA has requested associated GIS files; none were provided by USACE for the minor changes at the Diversion Channel.

<u>Sheyenne River Sovereign Lands Permit</u> - RRVA submitted their supplemental information on October 6, 2024, and we are awaiting NDDWR's issuance of the permit.

Cultural Monitoring

Cultural monitoring at Site 14/TR-9 (Sheyenne Aqueduct area) continued until Thanksgiving when conditions no longer allowed work, likely until Spring 2025. Site 16 (Horsehead) was completed on October 28th and RRVA will issue their report for us to obtain USACE concurrence.

Mussel Salvage

Discussions continue with USACE regarding their involvement in mussel salvage with no definitive resolution yet.

Spills, Contamination and Hazardous Materials

A hydraulic fluid spill of approximately 10 gallons occurred on 31-Oct-24 in Reach 13 which was reported to us on 1-Nov-24

All spills are reported to NDDEQ and cleaned up accordingly.

Environmental Nonconformances

No environmental Nonconformances were closed this month and no new environmental Nonconformances were issued.

RESILIENCE AND SUSTAINABILITY

Resilience

The Resilience 2023 Annual Report originally submitted on January 31, 2024, was resubmitted in October and a response sent back with comments; a meeting has been set for December 16th to hopefully close all comments.

The Monthly Status Updates (MSUs) for January 2024 through September 2024 were rejected incomplete; October's MSU is under review.

Appendix M Proposal Commitments remain an issue. A response letter was sent on October 8th regarding unfulfilled Appendix M Proposal Commitments, which is awaiting a response from the Developer. A meeting has been set for December 17th to review the commitments and hopefully come to a meeting of the minds on requirements.

Sustainability

RRVA's Sustainability efforts outside of the PA are focused on: 1. Education and Skills; 2. Renewable Energy; and 3. Culture & Heritage. The second monthly update meeting was held on November 13, 2024, and included an update on current RRVA sustainability activities as follows:

- The Developer donated 200 elm trees to Moorhead and 300 to West Fargo from those remaining after tree planting was completed for the season.
- The Indigenous Advisory Council meeting was rescheduled due to participants' illness.
- The Developer spoke at Turtle Mountain Community College about the project and their aquifer, resilience, and economic development; interest was noticeable, and the Developer will report on any future activities.
- A conference of the Red River Basin Commission will be held in January in Grand Forks and a discussion of indigenous science (used to be called "traditional ecological knowledge" (used to be called "indigenous science") is planned.

Various education and collaboration efforts with West Fargo, a local non-profit in Fargo, and a private firm were made, results yet to be determined.

FEDERAL COMPLIANCE

Reporting

Staff is working with the Developer towards a more efficient and concise report for the 2024 FRC Annual Report which will be due January 31, 2024. This is important as WIFIA funding is planned to be used in 2025 and an audit by WIFIA any time thereafter is a possibility.

Davis Bacon

Certified payrolls for 2024 are being received and the first quarter's submittals have been compiled and reviewed; the rest of the year is under review for inclusion in the 2024 FRC Annual Report.

EMPLOYEE APPRENTICESHIP PROGRAM

The Employee Apprenticeship Program (EAP) 2024 Q3 Report was resubmitted and accepted.

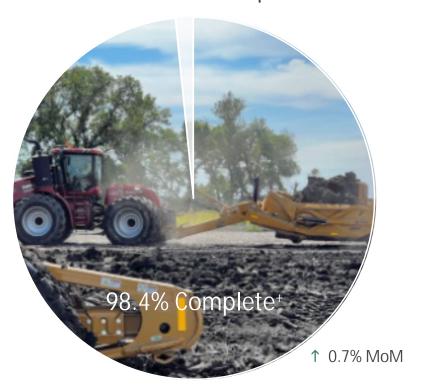




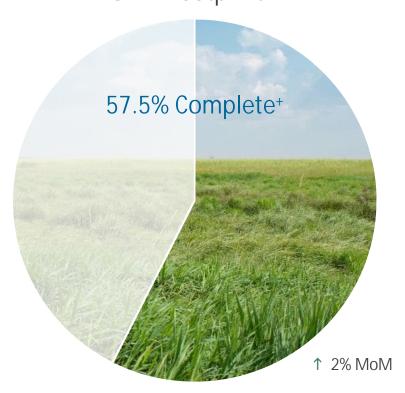
Property Acquisition Progress

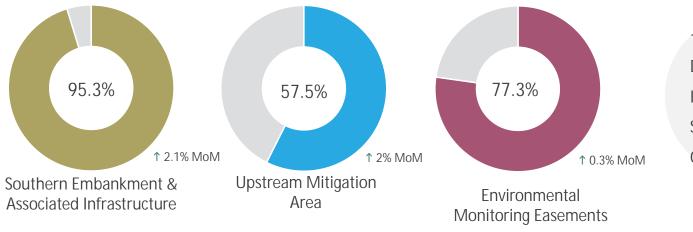

Property Acquisition Progress by Location (





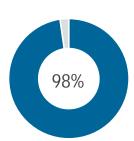

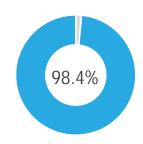

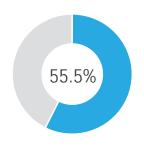
